

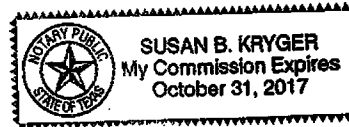

**CERTIFICATE OF AMENDMENT  
to the  
CERTIFICATE OF FORMATION  
(Formerly Articles of Incorporation)  
of

**Entity Information**

The name of the filing entity is Auburn Lakes Homeowners Association, Inc.

The filing entity is a nonprofit corporation.

The file number issued to the filing entity by the Secretary of State is 800249273.

The date of formation of the entity is September 22, 2003.

**Amendment**

Article 6 was amended to add the following Section (4) to read as follows:

(4) The corporation may be dissolved by the vote of the members representing not less than two-thirds (2/3rds) of the votes of the Class A members, which vote will be taken at a meeting of the members. Upon dissolution of the corporation, other than incident to a merger or consolidation, the assets of the corporation must be dedicated to an appropriate public agency to be used for purposes similar to those for which this corporation was created. In the event that such dedication is refused acceptance, such assets will be granted, conveyed and assigned to any nonprofit corporation, association, trust or other organization to be devoted to such similar purposes.

**Statement of Approval**

The amendments to the corporation's certificate of formation (formerly the Articles of Incorporation) were approved in the manner required by the Texas Business Organizations Code and by the governing documents of the entity by the affirmative vote of at least two-thirds (2/3rds) of the members of the corporation present in person or by proxy, at the annual meeting of the members of the corporation held on the 16<sup>th</sup> day of November, 2016 at which quorum was present.

**Effectiveness of Filing**

This document becomes effective when the document is filed by the Secretary of State.


